### PRIVATE POLICY

Please read the following terms carefully:

#### 1. Scope of This Privacy Policy

This Privacy Policy describes how the Website collects, processes, and protects personal data obtained during your use of Website services.

This Policy does not apply to external websites linked from this Website, nor to individuals or organizations not officially appointed by FANARO to operate or manage this Website.

#### 2. Collection, Processing, and Use of Personal Information

Such information will be processed and used only for that stated purpose, unless FANARO receives your explicit written consent for additional use.

During general browsing, the system automatically records information such as your IP address, browser type, browsing behavior, and clicks. This data is used internally for performance analysis and service improvement, and will not be publicly disclosed.

For service quality enhancement, FANARO may conduct statistical analysis based on survey responses. Summarized findings may be published when necessary, but they will not include personally identifiable information.

#### 3. Data Security and Protection Measures

The Website is equipped with multiple information security systems—including firewalls, intrusion prevention, and anti-virus protection—to safeguard your personal data. Only authorized personnel may access your information, and all such personnel are bound by strict confidentiality agreements. Any violation will result in legal consequences.



When the Website engages external service providers to assist in data processing, FANARO requires them to comply with confidentiality obligations and conducts necessary audits to ensure adherence.

#### 4. External Website Links
